# MINUTES OF THE 384TH BOMB GROUP, INC. ELEVENTH REUNION BUSINESS MEETING

The Eleventh Reunion Business Meeting of the 384th Bomb Group, Inc. was Called to Order by the President, Nathan H. Mazer(UT) at 9:00 AM, Saturday, October 1, 1988 at the Hyatt Regency Hotel, Savannah, Georgia. The Chaplain, Father Method C. Billy (NY) was called to offer the Invocation. This was followed by the Pledge of Allegiance to the Flag of the United States of America led by the President, Nathan H. Mazer (UT).

A short introductory speech was made by the President, Nathan H. Mazer (UT) who then introduced and turned the meeting over to the Chairman, Lloyd Whitlow (CA). The Chairman said a word of thanks to the President and then commented on the large turnout for the Eleventh Reunion.

The Board of Directors were then introduced, all twelve Directors were present and seated at the Head Table: Samuel R. Arauz (PA), Chairman Lloyd W. Whitlow (CA), President Theodore Rothschild (NY), Executive Vice-President Joe R. Carnes, Jr. (TX), Senior Vice-President Nathan H. Mazer (UT), Vice-President Walter L. Harvey (FL), Vice-President Frederick Nowosad (NJ), Secretary/Treasurer Gerald B. Sammons (IL), Member Fred Hewins (NJ), Member Alfred D. Hesko (OR), Member Stephen J. Kasmerski (GA), Member Wilford J. McNeill (MO), Member

The Acting Secretary, Stephen J. Kasmerski (GA) read the Minutes of the Tenth Reunion which was held at the Weston Crown Center Hotel, Kansas City, Missouri in November 1986. The Minutes were approved as read...

The Chairman then called on the Secretary to read the Correspondence, as there was no Correspondence the Chairman called on the Treasurer, Fred Nowosad (NJ) for the Financial Report. The Treasurer introduced the 384th Bomb Group CPA, John Mitros, who files the 384th IRS Forms, Prepares and Audits our Accounts. John, along with his wife Kathy, were attending the Eleventh Reunion as Guests of the 384th. The Treasurer, Fred Nowosad (NJ) then read the Financial Statement for the Year ending December 31, 1987, the Account was read in detail...the Chairman called for the Financial Statement to be approved as read... it was approved unanimously.

Next the Treasurer, Fred Nowosad (NJ) gave his report on the Financial Account for the Year 1988 up to but not including the Eleventh Reunion . . . as this was an incomplete and unofficial report no approval was required . . .


The Treasurer said that if any member desired to examine or read the Financial Accounts, the Books would be available for examination after the Meeting.



The Chairman, Lloyd Whitlow (CA) called on the President, Nathan Mazer (UT) to preside over the Old Business...

The President called on Joe Carnes (TX) to report on the changes made to the By-Laws of the 384th Bomb Group, Inc. He explained that the changes were made during the Board of Directors Meeting, January 1987. He further explained that the By-Laws had never been changed . . . altered, or revised since the 384th Bomb Group was Incorporated in 1967. He also explained that the changes were made to conform to the 384th Bomb Group, Inc. present method of operation. He explained that all of the changes had been thoroughly examined and discussed in detail by the Board of Directors and that the amended By-Laws had been unanimously approved by a vote taken by the Board of Directors. Joe Carnes (TX) then read and explained the changes made to the By-Laws, after this reading he presented the By-Laws to the members for their approval...the By-Laws of the 384th Bomb Group, Inc., as amended, were approved unanimously...

Next on the Agenda was the Report on the findings made by the St. James the Apostle Parish Church Restoration Project Committee. The report was made by the President, Nathan Mazer (UT). He explained how the Project had been originated in October 1985 by Arthur McNamara (CT), and how it was presented to the members during the Tenth Reunion Business Meeting, at which time a Committee was approved to gather information. It was also established that this was the Comittee's only function: no Contracts were to be signed; nor would the Committee make any commitments, and that the information gathered by the Committee would be presented during the Eleventh Reunion Business Meeting, which Nate explained, he was now doing...he told of the first meeting of the Church Committee held at the Ponce de Leon Hotel, St. Augustine, Florida in January 1987. At that time it was decided members from the Committee would make a trip to England to meet with the Peterborough Diocese and other interested parties. This meeting took place in May 1987. In January 1988 another meeting by the Church Committee was held at the Ponce de Leon Hotel where the entire project was reviewed with considerable discussion. Nate then read a letter of great importance, composed by the President of the Board of Directors, Lloyd Whitlow (CA), which was sent to Barbara Bland, Church Warden and Project PCC, this letter clarified the position of the 384th Bomb Group, Inc. in respect to the St. James the Apostle Parish Church Restoration Project . . . Copies of the Updated Report on the finding made by the Church Committee about the Church Restoration Project were made available to the members present . . .

Quentin Bland (Eng) was called on by Nathan Mazer (UT) to give a report on the Church Project in respect to the British point of view and what their priorities were

for the Restoration of the Church. He also told of the tremendous interest shown by the people who visit the Church to view the 384th Bomb Group Memorial Stained Glass Window.

Nathan Mazer (UT) then called for members who would like to speak on the subject, either pro or con...

Ted Rothschild (NY) was the first to speak and he explained why and how the Project had started...

Bill Harvey (FL) was next to speak and he stressed that the Church Restoration Project should not be an Official Project of the 384th Bomb Group, Inc., but should be strictly a voluntary activity and that the contributions made by the 384th Bomb Group members should be on a voluntary basis. . .

Jerry Jerome (VA) suggested the possibility of contacting the 8th Air Force Historical Society for their support and use as a publicity source for the Church Project. Nate Mazer (UT) explained the 384th Bomb Group, Inc. policy and position in regards to our projects...how we have always stood on our own, and we never have, nor shall we ever go out of our own bailiwick...

Henry Heckman (IN) made a statement in regards to the 8th Air Force Historical Society and their problems. He asked that the 384th Bomb Group, Inc. not ask for any support from the 8th AFHS...

Jim Orr (IL) asked about the possibility of the Church being closed by the Peterborough Diocese. Quentin Bland (Eng) explained that there were no guarantees, but historically if a Church was in good condition the chances of its closing was very remote. . .

Sam Gardner (TX) brought up the question about asking for Pledges towards the Church Project...

Fred Nowosad (NJ), Secretary/Treasurer of the Board of Directors, said that at the present time his work load was too heavy for him to be able to handle any additional work load, and as he understood it, the Church Project would not be an Official Function of the 384th Bomb Group, Inc., this being the case he suggested that all of the mailings, correspondence, monies, etc. connected with the Church Project be handled by a Special Project Committee. . .

Nathan Mazer (UT) wrapped up and summarized the conclusions reached in regards to the Church Restoration Project...as understood...the Church Project will not be an Official Project of the 384th Bomb Group, Inc., it will be a Voluntary Activity and from hereafter will be known as the, "Church Activity". There will be a Special Church Activity Committee who will handle the complete operation of the Church Activity. This Special Church Activity Committee will be composed of: Theodore Rothschild (NY), Chairman; Arthur M. McNamara (CT) and Walter L. Harvey (FL), Members. At the end of the Eleventh Reunion Business Meeting

the Church Activity will be, "Kicked Off" by inviting the members present to make their contributions to the Church Activity. . .Ted Rothschild (NY) will be available to accept the monies, either Cash or Check. . .for Tax Purposes all the Checks should be made out, "Pay to Order of the 384th Bomb Group," Inc. A separate mailing will be sent to all the members of the 384th Bomb Group, Inc. asking for their contributions towards the Church Activity. This letter will explain what has transpired and will include a self-addressed stamped envelope. It was explained that the cost for this mailing would be at the direct expense of the three men on the Church Activity Committee. No monies would be used from the 384th Bomb Group, Inc. Bank Account.

It was explained that a vote was not required for the Church Activity as this was a Voluntary Activity. . . Sam Gardner (TX) placed a motion on the floor to support the Project as a Voluntary Activity. . . this motion was passed by an unanimous vote of approval.

Bill Harvey (FL) brought up the question that the Church Activity was an excellent excuse for another Memorial Junket to England...Lloyd Whitlow (CA) explained that the plans and program for Memorial Junket VI have been prepared and all that is required is for a date to be set and the program can be implemented.

Next under Old Business was the report on the Redesignation of the 384th Bomb Wing (H) at McConnell Air Force Base, Wichita, Kansas. Cletus Pottebaum (KS) made this report and he explained about the Redesignation Ceremony held on July 1, 1987 attended by members from the 384th Bomb Group (H). He told about the new 384th Bomb Wing and their enthusiasm in being able to carry on the Heritage and the Traditions established during World War II by the 384th Bombardment Group (H). He told of the 28 members of the 384th Bomb Group who also attended the Arrival Ceremony for the B1-B on February 29, 1988. He told about General Theodore R. Milton flying the B1-B from McConnell. Lloyd Whitlow (CA) then told about the request from McConnell for the 384th Bomb Group to supply names for the B1-B Weapon Systems Training Instructor Teams. The Teams to be named for two of our outstanding Combat Crews. The letter was read which had been mailed to McConnell suggesting two Combat Crews who stood out just a bit more than some of the other Combat Crews. . . these were the Crew of Thomas J. Estes, using the name of their B-17, "Wearie Willie", and the Crew of Charles F. Gowder, the most highly Decorated Combat Crew in the 384th, using the name of their B-17, "Liberty Run".

Next on the Agenda was the report given by Nathan Mazer (UT) on the Memorial Stained Glass Window for Hill Air Force Base, Ogden, Utah...he reported the present status of the Project...how the Window was fabricated by Chapel Studio, Kings Langley, England, he told of the trip to England by Lloyd Whitlow (CA), Nathan Mazer (UT), and Clete Pottebuam, (KS) in May

of 1988. This included a visit to Chapel Studio, arranging for the transport of the Window to Mildenhall Air Force Base, England for Shipment to the U.S.A., how the Window was transported to Hill Air Force Base by a 384th Bomb Wing KC-135R and how it was escorted by Nate Mazer (UT). He further explained why the Dedication Ceremony was delayed and about the plans for the Dedication Ceremony to take place sometime in 1989. Complete details about this will be forthcoming in a Newsletter.

Bill Harvey (FL) told of his trip in May 1988 to the Air Force Academy and gave a report on the Eagle and Fledgling Sculpture which is Awarded to the Outstanding Graduating Cadet in Biology. This Award is Sponsored by the 384th Bomb Group, Inc. He explained that this award is given to all the outstanding Graduates for each Academic. Subject, Military Achievement, and Athletics. He explained about the presentation made by Bill Harvey (FL) and Lloyd Whitlow (CA) to the Academy of a picture of our Memorial Stained Glass Window, a Plaque telling the History of the Group, and a model of a 384th B-17. He read the letter received from Colonel Sampson, Biology Department Head, thanking the Group for our support and the presentations made to the Academy and how they would be displayed in a prominent place. he also explained how much the Heritage and the Traditions of the 384th meant to the Academy Cadets.

### New Business...

Lloyd Whitlow (CA) called for the presentation of Sites for the Twelfth Reunion... prior to the presentations being made, Fred Nowosad (NJ) was called on to read the Procedures for Site Presentations. Nathan Mazer (UT) called on Cletus Pottebaum (KS) to present Wichita, Kansas for consideration as the Site for the Twelfth Reunion. Clete gave an excellent presentation which included the connection between the new 384th Bomb Wing (H) and the old 384th Bomb Group (H) and how the 384th Bomb Wing would be the Host for the Twelfth Reunion.

Stuart Gordon (NJ) presented the Biggest Little City in the World...Reno, Nevada. He explained the various attractions in and around the Area.

There being no other Sites presented a vote was in order. . . prior to the vote being taken, Fred Nowosad (NJ) explained some of the problems encountered by the Reunion Committee in the past; that because of this he was proposing a new procedure for site selection. This would be the selection of a Primary and a Secondary Site. . . this would give the Reunion Committee some latitude in their contracting for Hotels, etc. It was further explained, that the site would not be moved from the Primary Site until all the avenues had been explored, and if it were necessary to move the Site to the Secondary Site a notification about the reasons for the move to the Secondary Site would be

published in the Newsletter. The motion was placed on the floor to select a Primary and Secondary Site for the Reunions...it was so moved and passed by a majority vote.

A motion was placed on the floor to waive the secret ballot for Site Selection, as there were only two sites to be considered, neither site could lose as one would be the Primary Site, the other the Secondary Site. . . it was so moved and passed.

The vote for Wichita, Kansas was held first, the men on the left being counted first, then the men on the right...the vote for Reno, Nevada was then taken using the same procedure. The final count was 36 votes for Reno, Nevada, the balance of over 200 was for Wichita, Kansas.

The Site for the Twelfth Reunion of the 384th Bomb Group, Inc. will be held at Wichita, Kansas, this will be the Primary Site. . . the Secondary Site for the Twelfth Reunion of the 384th Bomb Group, Inc. will be Reno, Nevada.

As the report by the Museum Committee had been delayed, for this report the meeting reverted back to Old Business...

Bill McNeill (MO) was called on to give the Museum Committee report...Bill gave an excellent report explaining the proposed Museum for Kettering, England, how they have offered a room in the Museum for the exclusive use by the 384th Bomb Group, Inc. He gave a very comprehensive report on the requirements, costs, etc. The first Memorabilia for a Museum was presented by Bill McNeill (MO) to Quentin Bland (Eng), these were the pictures which had been on display during the Eleventh Reunion. He further explained that at a future date a mailing would be made to the membership for their consideration for the Project.

The meeting reverted back to New Business and the last item on the Agenda was the Election of the Twelfth Reunion Officers. Per the Motion passed during the Tenth Reunion Business Meeting, as selected by the Election Committee, the Slate of the Proposed Twelfth Reunion Officers had been posted for all to read in the Memorabilia Room.

The Inspector of Elections, Fred Hewins (NJ) was called on to read the Slate of Proposed Twelfth Reunion Officers...
